

The Minutes of the Council of the
Village of Luckey

The Regular meeting of the Council of the Village of Luckey was held on June 25, 2014 at 7:00 p.m. in the Municipal Building, with the following members present: Richard Heilman, Mike Franklin, Mike McNulty, Chad Arntson, Joshua Mitchell, Village Administrator Randy Bielinski, Mayor Belinda Brooks and Fiscal Officer Connie Heflin. Donald Brickner was absent.

The minutes of the Regular Meeting held on June 4, 2014 were presented to Council and read. Michael Franklin made a motion to accept the minutes as read. The motion was second by Joshua Mitchell. Vote: all-yes, motion carried.

Richard Heilman made a motion to pay the bills as presented. Michael McNulty seconds the motion. Vote: all-yes, motion carried.

Mayor Brooks recognized guest Joel Davis. Mr. Davis had complaints about the water lying in the streets. Mayor Brooks stated that monies were not available to fix the problem at this time, but someone would look into the matter.

Mayor Brooks also recognized guest, Kerry Tuttle, Jen Bengner, and Julie Baker. The guest were complaining about the problems with not having a street address in town and being made to use Post Office box numbers as their official address.

Richard Heilman made the motion to purchase batteries for the portable radios at the replacement cost of \$ 268.65. Chad Arntson seconds the motion. Vote: all-yes, motion called.

Joshua Mitchell made a motion to have Dylan James join the auxiliary police department. Michael McNulty seconds the motion. Vote: all-yes, motion carried.

A discussion was held on repairs needed to the police cruiser, Norris reporting system and the replacement of the cruiser

Joshua Mitchell made a motion to purchase an additional 50 yard of playground mulch. Chad Arntson seconds the motion. Vote: all-yes, motion carried.

Randy Bielinski Village Administrator spoke about issues with paving Quarry Lane.

Council requested the clerk to prepare the resolution for renewal of 1.9 current expense levies.

Mike McNulty made a motion to go with the Walter Drane Co. for codifying of the Ordinance at the cost of \$ 11,600.00. Chad Arntson seconds the motion. Vote: all-yes, motion carried.

Joshua Mitchell made a motion to move the August 6th meeting to August 13th. Mike McNulty seconds the motion. Vote: all-yes, motion carried.

Richard Heilman made a motion to form a tree committee. Joshua Mitchell seconds the motion. Vote: all-yes, motion carried.

At 8:26 PM. a motion to adjourn was made by Richard Heilman, seconded Michael Franklin. Vote: all-yes, motion carried.
