

The Minutes of the Council of the  
Village of Luckey

The regular meeting of the Council of the Village of Luckey held on April 17th, at 7:00 p.m. and was in the Municipal Building. The following members were present: Councilpersons: Alison Okenka, Richard Heilman, Mike McNulty, Michael Franklin, Don Brickner, Mayor Cory Panning, the Village Administrator Randy Bielinski, Solicitor Corey Speweik and Fiscal Officer Barb Rizzo. Absent from the meeting was Pat Covarrubias.

The Mayor led the Pledge of Allegiance.

The mayor thanked all of the visitors for coming to the meeting.

The mayor asked if any of the visitors would like to speak during the meeting.

Steve Snyder addressed the council regarding the continuing liter problem on Locust and Lime Street and also the blowing liter on Luckey and Locust. Steve Snyder wanted to make the Village aware of the problem areas. Steve Snyder said some of the garbage found has names and addresses located miles away and the northeast winds make a disaster. Steve Snyder mentioned a possible fence to catch the garbage.

Belinda Brooks mentioned the eminent domain and moving forward inquired if there will be houses built in that area. Additionally, Belinda Brooks mentioned the amended income tax Ordinance passing on 02-21-2024 and why there was no description. Three weeks later criminal and civil violations occurred and wanted to know why the tax administrator was not here and why it was not online. Belinda said she was concerned about identity theft and mentioned Ordinance 842, she is concerned about who is doing the taxes for the Village.

Scott Dodd mentioned that the alley between Park and Ash need corrected and was brought several years ago as water is in his garage still and would like a resolution.

New Business:


Jameson King to present Eagle Scout Project to council. Jameson King presented a summer project completed by the for the Village of Luckey which is a Welcome to Luckey sign.
